About Affiliate Membership

Affiliate Membership is a special category of membership reserved for individuals who *are not* actively engaged in the real estate profession, but who have an interest in the activities of the association, including access to resources, programs, services and information. Affiliate Membership is open to qualified individuals whose firms and businesses offer goods and services used by real estate professionals and/or their clients and customers.

Qualifications

Applicants for Affiliate Membership must meet the following minimum requirements:

- Ownership, employment or affiliation with a legally recognized business or corporation authorized to do business in State of Massachusetts
- The applicant's business entity is fiscally and financially sound
- The applicant's business entity is reputable

The annual membership dues for a GBAR affiliate individual membership is \$395. For affiliate members who join halfway through the year, July through December, the membership dues will be prorated to \$200 for the individual GBAR affiliate member.

In addition, we also offer group affiliate membership rates. The annual membership dues for GBAR affiliate group membership is \$695 for up to four members from the same office or branch location. For any members that wish to join as a group affiliate member after July 1st, the price will be \$350 for an office or branch location up to four.
