Course Description

The Accredited Buyer Representative® (ABR®) Designation is the benchmark of excellence in buyer representation and is the only buyer representative designation recognized by the National Association of REALTORS®. Following are the overall goals of the ABR® designation course:

- Understand and demonstrate your value to today's buyer.
- Acquire the skills and resources to succeed as a buyer's representative in a dynamic real estate market.
- Help buyers find the right property at the right terms and price in both buyer's and seller's markets.

DESIGNATION REQUIREMENTS

- Completion of the Accredited Buyer's Representative (ABR®) Designation Course. After you complete this course you will have three (3) years in which to complete the other ABR® designation requirements.
- Completion of one of the ABR® elective courses. This course may be taken prior to completing the Accredited Buyer's Representative (ABR®) Designation Course.
- Present Five (5) completed and verified transactions in which you acted solely as a buyer's representative (within 36 months before or after the completion date of the class requirements).
- Be a member in good standing with REBAC® and NAR® (You receive a FREE one year membership to REBAC® when you take the course).
