- Massachusetts has experienced a strong recovery from the pandemic recession
- Knowledge-based industries continue to be important in the state's growth
- Prosperity has not been felt evenly throughout the state
- Demographic headwinds will limit economic growth in the coming years
- Domestic outmigration is a serious concern for the state
- Remote work remains significant in Massachusetts
- The state must attract and retain families, as well as maximize labor market engagement in the coming years to remain competitive.
- Housing is a critical part of any attracting and retention strategy





#### Massachusetts per capita income reached \$84,945 in 2022 — 30% higher than the national average


Per capita income by state, 2022



#### In the spring of 2020, unemployment reached historic highs and has since returned to pre-pandemic lows


Unemployment rates in Massachusetts and the United States as of September 2023 (Seasonally adjusted)

# More than three years into the pandemic, MA has now recovered from Spring 2020 jobs losses


Jobs deficit in Massachusetts relative to February 2020 peak in 1,000s (Seasonally adjusted)

#### The shutdown in Massachusetts was more severe than in most states, and MA ranked 45<sup>th</sup> in job losses in the U.S.


Job loss rates in Massachusetts and all states, February 2020 and April 2020 (Seasonally adjusted)

#### The shutdown in Massachusetts was more severe than in most states, and MA ranks 34<sup>th</sup> in job recovery in the U.S.


Job recovery rates in Massachusetts and all states, February 2020 and September 2023 (Seasonally adjusted)

## More than three years since the pre-pandemic peak, leisure & hospitality and retail trade are still very slow to recover



#### MA outpaced the US in professional services, finance/insurance, and leisure/hospitality; fell short in manufacturing & education/health services


Percent Change in Employment by Industry, September 2022 - September 2023

# Greater Boston lags other areas of the state in jobs recovery but is approaching pre-pandemic employment


Job recovery rates in Massachusetts' MSAs, February 2020 and August 2023 (seasonally adjusted)

#### Massachusetts GDP grew consistently over the last half of 2022 and first half of 2023, by the end of that period outpacing the US


Quarterly Change in GDP for MA, US, and MassBenchmarks Projections, 2021-2023

#### The labor force has not recovered to pre-pandemic levels


Massachusetts Labor Force, January 2018 – September 2023 (Seasonally adjusted)


#### The labor force in Massachusetts is projected to grow at a significantly slower pace over the next 30 years

Projected Massachusetts Labor Force through 2050 (Seasonally adjusted)






#### Massachusetts labor force participation rates by demographic groups

#### Massachusetts is experiencing a historically high job openings rate which vastly exceeds the hire rate


Job openings rate and hire rate in Massachusetts, December 2000-August 2023 (Seasonally adjusted)

#### MA's quit rate has returned to its historical average, while the US is still experiencing an elevated rate


Job quits rate in Massachusetts and the United States, December 2000-August 2023 (Seasonally adjusted)

#### The Northeast and Boston Metro have closely tracked the overall inflation trajectory in the US, including the recent drop


Inflation Rate for U.S., Northeast, and Boston-Cambridge-Newton, MA-NH MSA, January 2011 - September 2023

#### Boston fuel & utilities prices have retreated from high prices last year; shelter and food price increases have been steep


Year-over-Year Inflation in Boston MSA and United States







#### Massachusetts population growth depends on international migration




#### Suffolk County has seen a large out-migration during the pandemic; international migration is recovering






#### The Cape and Islands had a spike of in-migration during the first year of the pandemic; in 2022, trends returned to pre-pandemic levels




#### The Berkshires also saw, albeit a more modest, boost in domestic in-migration that has since reversed as well

#### Massachusetts experiences the most churn in residential migration in its collegeaged and immediately post-college cohorts



## Massachusetts experiences the most churn in residential migration in its collegeaged and immediately post-college cohorts


Age Profiles of Net Migrants from Massachusetts, 2019 & 2021

#### Professional and business services were more likely to move out of Massachusetts in 2021 compared to service industries


Migration by Industry, as Percent of Total Industry Employment, 2021


#### New Hampshire and Florida are the top destinations for MA out-migrants


Net Migration to and from Massachusetts, Top 5 States, 2020-2021

#### Massachusetts had among the highest out-migration rates of Northeast states, opposed to other New England states with high in-migration such as Maine and New Hampshire



Year-Over-Year Percent Change in Population, MA and Counties, 2020-2022



#### Massachusetts has the sixth-highest rate of remote work in the United States


Percentage of workers who work from home, 2022


#### Workers with at least a four-year college degree as well as Asian or white workers are more likely than average to work from home in MA

Percent of workers who worked from home in Massachusetts by demographic groups, 2021




#### Jobs in STEM, technical, and financial fields are proportionally more likely to have workers who telecommute; sectors and occupations in health care and education also employ many remote workers

Percent of workers who worked from home in Massachusetts by industry and occupation, 2021




#### Black, Hispanic/Latino, and workers of other racial groups were much less likely to work from home across a variety of industries

Percent of workers who worked from home in Massachusetts by race/ethnicity and select occupation groups, 2021






#### Remote work occurs throughout the state but is concentrated in the Boston metro area and Middlesex County

#### After housing price increases fell from pandemic highs, the Boston area prices have begun surging again


Zillow Home Value Index from 2010 to September 2023 (in 2023 \$)

#### Rental increases have been higher in the Boston area as well compared to the US


Zillow Observed Rent Index from 2016 to September 2023 (in 2023 \$)

#### The Boston Metro experience large housing cost increases over the past 10 years, including pre-pandemic when inflation was otherwise moderate


Housing Inflation Rate for U.S., Northeast, and Boston-Cambridge-Newton, MA-NH MSA, January 2011 - September 2023

## Massachusetts renters are similarly cost burdened compared to the nation, while our homeowners are more likely to be cost burdened


Housing-Cost-Burdened Households in Massachusetts and the United States (Spending 30 Percent or More of Income on Housing Costs)

#### Almost I in 4 renters in Massachusetts and the US pay half or more of their income toward housing


Extreme Housing-Cost-Burdened Households in Massachusetts and the United States (Spending 50 Percent or More of Income on Housing Costs)

#### Especially for Black and Hispanic households, housing cost burden tends to be more prevalent in Massachusetts compared to the nation


Housing-Cost-Burdened Households in Massachusetts and the United States by Race/Ethnicity


#### Boston, North Shore, Hampden County, and Cape Islands are particularly housing cost burdened

Massachusetts Living Wage (Household Income) and Median Housing Costs in Massachusetts, 2022 (in 2022 \$)




Housing costs for owners with a mortgage would account for 29% of income for a family earning a living wage

#### On October 18th, the Healey-Driscoll Administration released details on the forthcoming Affordable Homes Act

\$4.1 Billion

Proposed new spending to promote new construction, renovate existing public housing, and support existing affordable housing

New Policies

Simplify some types of development (ADUs, state-owned land, transit-oriented development), adjust public housing regulations, and support new state-wide planning

Tax Credits

New and expanded credits aimed at homeownership and **Community Development Corporations**
